Information Memorandum to Shareholders of PJSC "Rosseti Lenenergo" about the Dividend Payout Terms

Payout Term

Payout to the nominee holders or trustees who are securities market professionals will be made within ten (10) or less business days from the Record Date (List of Eligibles date), and payout to other registered persons will be made within twenty-five (25) business days after such date.

Payout Procedure

Cash dividends payable to the registered individuals will be transferred to their bank accounts or dedicated financial platform accounts opened in accordance with the Russian Federal Law titled Making Financial Transactions Using Financial Platforms communicated to the Registrar. If such bank or dedicated accounts have not been communicated to the Registrar, the latter will arrange for the dividends to be remitted by post. In case of other registered persons, dividends will be paid to their bank accounts.

Eligibles who have nominees receive their payouts in cash subject to the Russian securities regulations.

To be able to properly implement the payout procedure and update the information contained in the Register of Shareholders of PJSC "Rosseti Lenenergo", please inform the Registrar of any change of your details (name, bank details, addresses, personal data, particulars, etc.)

- 1. To be timely updated about the General Meeting procedures via text messages, please give your mobile number to the Registrar.
- 2. Please make sure that the Registrar has your email address to receive general meeting bulletins in time.

For your convenience, bulletins can be emailed to you for you to:

- Save your time instead of picking up your registered mail from a post office
- Help the Company spend less by not mailing your bulletins.
- 3. For your convenience, you can let the Registrar know your bank details for your dividends to be transferred to your bank account.

If you use this option, you will:

- Receive your dividends faster than if they were remitted by post
- Receive your dividends without delay (a payout will not be sent back to the Company, which happens if a shareholder fails to receive their dividends within the prescribed term if they were remitted by post).
